

In Canada Disability Poverty Begins at Birth







Lifetime Caregivers & Children with Disabilities are Excluded From Federally Funded Programs



Canadian children with severe & prolonged disabilities & their caregivers are excluded from federal government policy / program development

Significant barriers to employment excludes lifetime caregivers from income, workplace benefits & CPP contributions

Canada Recovery Caregiver Benefit excluded lifetime caregivers that had to leave employment at their child's birth

Multigenerational Home Renovation

Tax Credit: (Only for 18+ to senior) Disabled children & youth are excluded Child Care Benefit: Children with complex needs are discriminated & denied access. Child Care centers frequently refuse or unable to accommodate

Existing El Caregiver Benefit:

Child cannot have a pre-existing medical condition



The Neha review panel released its terms of reference and a form to fill out, which includes the privacy notice, and person's details, and its **FIVE QUESTIONS:**

1. Vision: What is your vision for safe, adequate, and affordable housing for women, Two Spirit, Trans, and gender-diverse people? For example, what are your hopes and dreams for yourself, your family, your community, and for future generations? What is your vision for all women, Two Spirit, Trans, and gender-diverse people now and for generations to come?



2. Knowledge: What knowledge can be used to inform or support this vision?

For example, in your experience, what has helped to support you or others in your community to secure safe, adequate and affordable housing?

What hasn't helped? Do you have research, reports or other evidence that support your proposed vision?



3. Reason: Why is this vision important?

For example, what is preventing access to safe, adequate, and affordable housing for women, Two Spirit, Trans, and gender-diverse people? How does this lack of access affect you, your family, and your community? How does it affect all women, Two Spirit, Trans, and gender-diverse people? How would things be different if this vision were realized?



4. Action: What actions are needed to make this vision a reality?

For example, what actions are needed to make a home for yourself or your family? What can women, Two Spirit, Trans, and genderdiverse people do to claim their right to safe, adequate and affordable housing? What actions should be taken by governments, service providers, and others who have the power to make a difference?



5. Is there anything else you want us to know about you to understand your comments better? For example, age, gender, Indigenous identity, race, immigration experience, disabilities, sexual orientation, family status, background, faith, or anything else you wish to share.

1. Online Submission


- Complete the online form.
